

The 2nd Annual Chris Lucius Memorial Foundation Bass Tournament May 17, 2025



Official Tournament Rules

Bay Springs Marina, 48 Co Rd 3495, New Site, MS 38859

- 1. Entry form must be completed, signed and remitted with complete payment before start of tournament.
- 2. Early entry fee is \$200 per boat from December through March.
- 3. Late entry fee is \$225 per boat from April 1st through May 17th.
- 4. Early registration takes place by filling out an entry form and remitting payment in one of these methods:
 - **a.** *Cash and this entry form mailed with to: Eddie Timmons, 1694 Forest Hill Lane, Belden, Ms. 38826
 - b. *Checks are only accepted before May 1st and must be made payable to Chris Lucius Memorial Foundation and Mailed with this entry form to: Eddie Timmons, 1694 Forest Hill Lane, Belden, Ms. 38826 662-871-3728
 - c. *Credit Cards are used through Square App which give us QR codes and links to use online and the ability to scan cards in person.
- 5. *Payment must be received prior to tournament start.
- 6. *Tournament is not responsible for slow mail.
- 7. Onsite Registration and Tournament check-in starts at 4am.
- 8. Tournament begins at safe light and ends at 3pm.
- 9. Safety is of the utmost importance; therefore, speed limits and all other applicable laws will be strictly adhered to.
- 10. Failure to adhere to all rules will render participants disqualified from this tournament and ineligible for a refund.
- 11. There is a strict **limit of 5 fish** per boat.
- 12. Penalties will be given for each dead fish as follows:
 - a. 1 dead fish = deduction of 1-pound from total weight
 - b. 2 dead fish = disqualification
- 13. Anglers assume all responsibility for their personal safety and that of their personal property.
- 14. Anglers will be respectful of their surroundings and courteous to other anglers.

15. Prizes will be awarded as follows:

- a. **1st Prize /\$5,000** will be awarded to the team with the 5 fish that have highest combined total weight.
- b. **2nd Prize /\$4,000** will be awarded to the team with the 5 fish that have second highest combined total weight.
- c. **3rd Prize /\$3,000** will be awarded to the team with the 5 fish that have third highest combined total weight.
- d. **4th Prize /\$2,000** will be awarded to the team with the 5 fish that have third highest combined total weight.
- e. **5th Prize /\$1,000** will be awarded to the team with the 5 fish that have third highest combined total weight.
- f. **The Alan Langford Lunker /\$1,000** will be awarded to the team with biggest fish.
- 16. Boat number will be assigned based on the date and time completed form and entry fee are received.
- 17. There will not be a number 2 boat, however, Jacob Langford and his co-angler will always be allowed to launch 2nd with waived entry fees.
- 18. Boat numbers determine launch order.
- 19. No more than 2 anglers per boat.
- 20. Early takeoffs will be disqualified.
- 21.All fishing stops at 3pm.
- 22. Anglers report to scales at 3:15pm for official fish weighing.
- 23. Failure to stop at 3pm and/or be late for weigh-in will result in disqualification.
- 24. Prizes distributed according to official weights.
- 25. Anglers who attempt to add weight to a fish will be disqualified.
- 26.By entering our tournament and accepting our prizes, anglers are agreeing to support the Chris Lucius Memorial Foundation by allowing it to use angler's name and photo in future publications and advertisements.
- 27.In the event of extreme weather conditions or other unforeseen catastrophes, the fishing tournament may be postponed or completely canceled.
- 28. The tournament directors will make the decision whether to fish, cancel or postpone.
- 29.If canceled, participants will not receive any payouts or prizes and entry fees will be refunded upon request.
- 30.If canceled, each angler who paid an entry fee and requests a refund will be mailed a refund.
- 31.If postponed, the payouts, prizes and entry fees will apply to the new date and refunds are not applicable.
